Living Here, Learning Here

The girls arrive on this Bennington campus from all parts of New England, as young as 11, as old as 20. They may have come with their parents or caregivers, this may be their first experience of living away from home, and they may be excited and eager—or skeptical, reluctant and even scared. But what they all have in common is that they have suffered a trauma that has interrupted their development, their education, and their chance to thrive as adults. While the residential school is new to them, the professional staff that welcomes them—a complement of educators, therapists, program specialists and residential advisors—is experienced and ready to receive them.

This month we have received a rare invitation to come to the campus of VPI South (Vermont Permanency Initiative South) to learn about a therapeutic community in our own backyard. The peaceful, tree-shaded community enables girls to heal from past trauma, enjoy their present lives, and build inner resources for their futures. Its two schools—Vermont School for Girls and New England School for Girls—provide specialized assistance and staffing at different levels, depending on student needs. A strong academic program—the standard middle and high school curriculum of mathematics, science, English, social studies and electives—is supported by residential, social, behavioral, and therapeutic services.

Guest speakers Kathy Houran and Lori Vadakin, both new branch members who bring their extensive expertise to their work at VPI South, will share stories about the kinds of emotional disturbances that lead these students to Bennington and the paths they travel to get here, with examples of the evidence-based treatment they receive once they arrive. We will learn about a few programs that have proven their effectiveness, from trauma-informed care to experiences that promote growth and secure relationships.

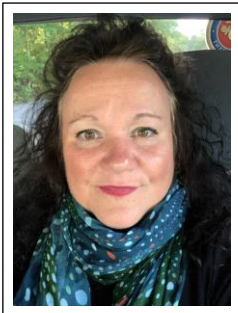
Kathy Houran, Special Education Director, received her BS in Human Services from Fitchburg State

Theater Fundraiser Was A Success!

The branch cleared \$672 from the Oldcastle Theater Fundraiser. Members bought 30 tickets and \$14 profit per ticket netted \$420 for the branch. Members who could not attend the performance sent in \$252 in contributions.

As in previous years, the Bennington Branch will contribute \$250 of the profits to the national AAUW Fellowships and Grant Program which has awarded \$3.9 million to 250 women and community projects for the 2018-19 academic year. \$422 will be added to our local AAUW Scholarship program for female non-traditional students at CCV in Bennington.

Next, candidates responded to the four questions members had prepared on minimum wage, the opioid epidemic, climate change, and health care. After those rounds of responses there were a few questions from the audience, including two questions related to health insurance, one on internet censorship, and one on education funding.

The formal part of the forum ended with the candidates giving closing statements. Most of the audience stayed to enjoy donuts and cider while continuing their conversations with the candidates.
